# MINUTES OF PILTON PARISH COUNCIL FULL COUNCIL MEETING held at Pilton Village Hall Wednesday 6 August 2025

Present: Cllrs: K Sumner, N Hall, R Noble, C Connock, T Moulder, L Roberts, R Woodhouse.

**In Attendance:** 5 members of the public present, Gill Pettitt (Parish Clerk), Cllr Clair Sully (Somerset Council).

# **PUBLIC QUESTION TIME**

Representation from the Chair of North Wootton Parish Council regarding flooding in the parish much of which is sourced from Pilton Parish waterways. Request for support in talking with landowners to discuss methods to reduce flooding such as choice of crops close to rivers, (maize and tree cutting is detrimental; modern grasses and herbal leys are effective against flooding). Noted that three large bore holes in West Compton, (a decommissioned source of water for Glastonbury and Pilton), constantly releases 1,000 ltrs water per hour. Cllrs Woodhouse and Sumner will discuss with the North Wootton Chair. Cllr Sully will contact local parishes dealing with similar issues.

Question regarding degraded gravestones - who is responsible and are the stones checked. Grave owners are responsible for their own plots and gravestones, however, Cllr Hall checks the burial grounds two weekly.

- a. Avon and Somerset Police no report. Agreed to remove this standing item.
- b. Somerset Council Cllr Sully reported on the NHS cuts of beds and services without consultation. Wells and Street City/Town Councils have written letters of concern. Staff are distressed. Somerset Council were not informed of the business case. Cllr Sully will share letters of concern for the Clerk/Chair to respond. Various complaints and suggestions were made about the recent A361 roadworks
  - Various complaints and suggestions were made about the recent A361 roadworks and subsequent traffic disruption. These will be sent to Highways to consider before recommencing the works.
  - Cllr Sully was asked to report on progress of the Strawberry Line.
  - Noted that the Boundary Commission is redefining ward boundaries. Pilton will now be with Shepton Mallet, with one ward councillor allocated. The Mendip South ward that Cllr Sully currently covers represents be disbanded.
