- sufficient for the loan repayment. Proposed Cllr Powell, 2nd Cllr Connock. Approved, Cllr Sumner did not vote. [Note: Whether GFEL conditions continue to apply to ring-fenced loan repayments will be discussed at the next meeting.] [Cllr Sumner took the Chair.]
- d. Grant Application from Glastonbury TrainLink. Cllr Hall introduced the application, and Suzanne Clements provided a presentation. It was noted that the proportion, £10,000 was large in comparison to Glastonbury Town Council's contribution of £14,000 given the difference in sizes of parish populations. RESOLVED: To defer a decision on provision of a grant to Glastonbury TrainLink to the July meeting. Proposed Clir Noble, 2nd Clir Moulder. Approved. Councillors were asked to send any questions to the clerk prior to the next meeting.
- e. Grant Application from Pilton Parish Bell Tower Fund, Maureen Tofts introduced the grant application for £1,000 to repair the St John the Baptist church bell tower. RESOLVED: To provide £1,000 to the bell ringers from the GFEL donation. Proposed Cllr Noble, 2nd Cllr Hall. Not approved. Cllrs Roberts, Moulder, Hollings, Connock, Powell and Sumner voted against the proposal. [Note: The GFEL donation conditions were open to varied interpretations. This will be brought to the next council meeting for clarification. 1
  - RESOLVED: To provide £1,000 to the bell ringers from the Parish Council general grant fund. Proposed Clir Powell. Approved with one against - Clir Noble.
- f. To approve (or not) additional cost to Community Speed Watch SID the hire charge for SIDS from the Community Speed Watch at £25 for two 2-week periods, plus additional mileage costs of £19.40 for each 2-week period.
